Fund Manager's Commentary

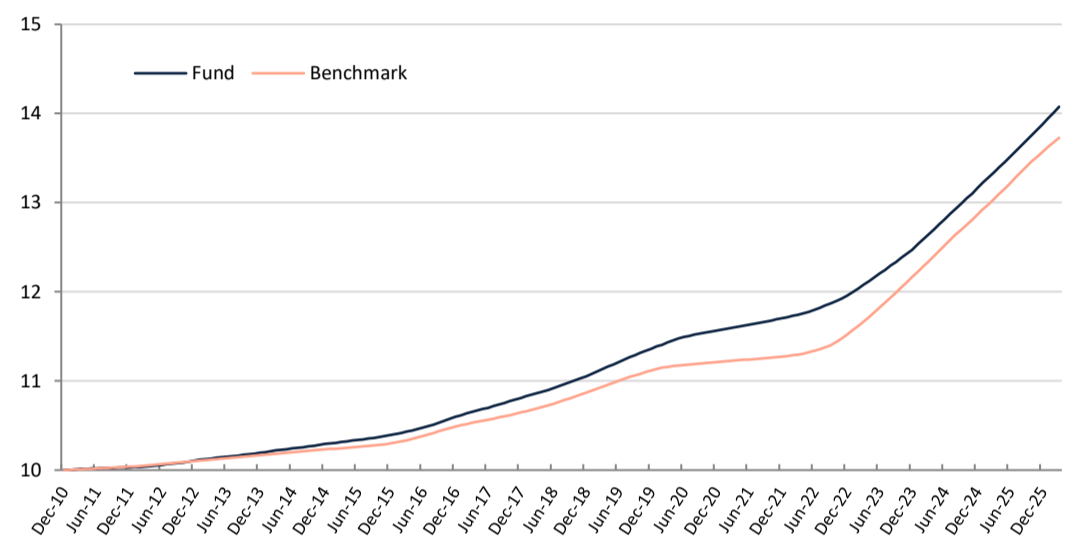

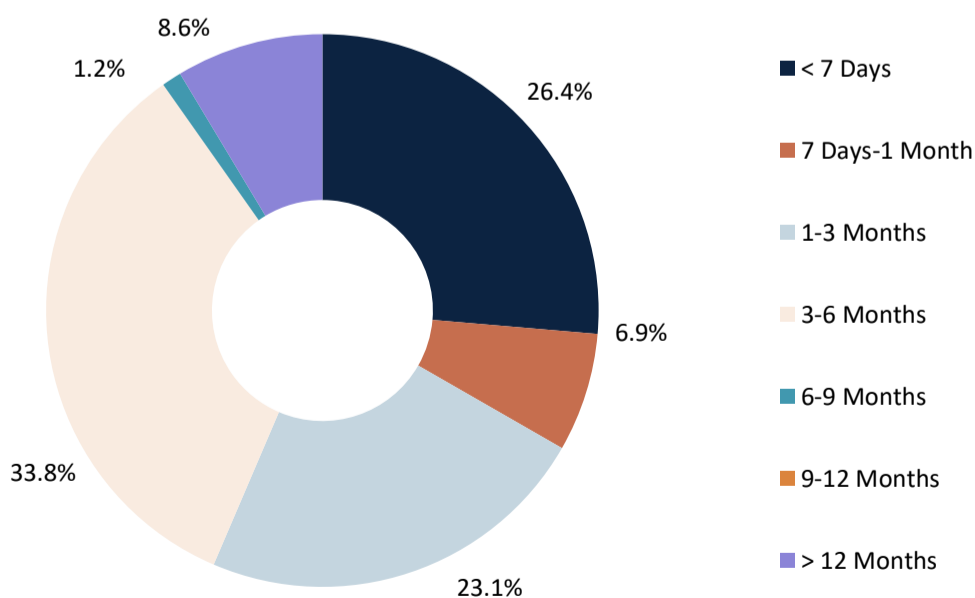

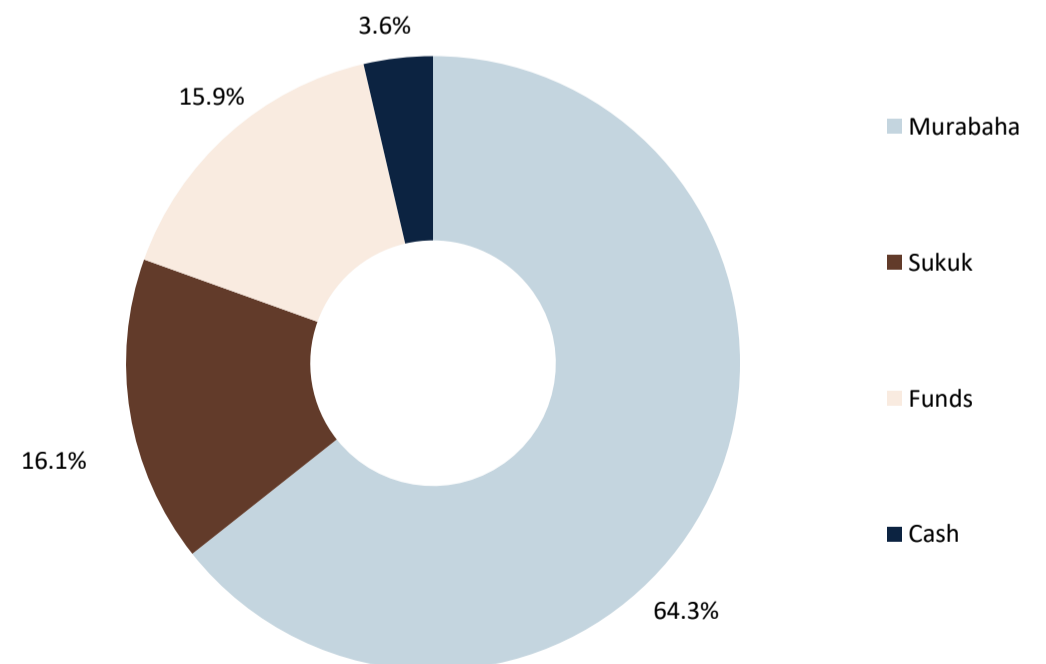
