## Fund Manager's Commentary

The Fund yielded a net YTD return of 5.45% as compared to 5.55% in the same month last year. On annualized basis, the Fund has recorded a net return of 5.45% outperforming the benchmark by 19 bps.

During the current month the average one-month SAIBID decreased by 3.1539% compared to the last month, and the month closed at 4.5672%






