#### Fund Manager's Commentary


The Fund yielded a net YTD return of 0.48% as compared to 0.44% in the same month last year. On annualized basis, the Fund has recorded a net return of 6.94% outperforming the benchmark by 152 bps.

During the current month the average SAIBOR 6 month increased by 1.1644% compared to the last month, and the month closed at 11.6631%




