Fund seeks to protect capital while achieving rewarding return through low risk investments like investing in commodities and metals Murabaha excluding gold and silver, investing in Sukuk and similar Sharia’h approved funds.

Fund Manager's Commentary

The Fund yielded a net YTD return of 2.77% as compared to 2.68% in the same month last year. On annualized basis, the Fund has recorded a net return of 5.60% outperforming the benchmark by 110 bps.

During the current month the average one-month SAIBID Decreased by 0.8304% compared to the last month, and the month closed at 4.4530%

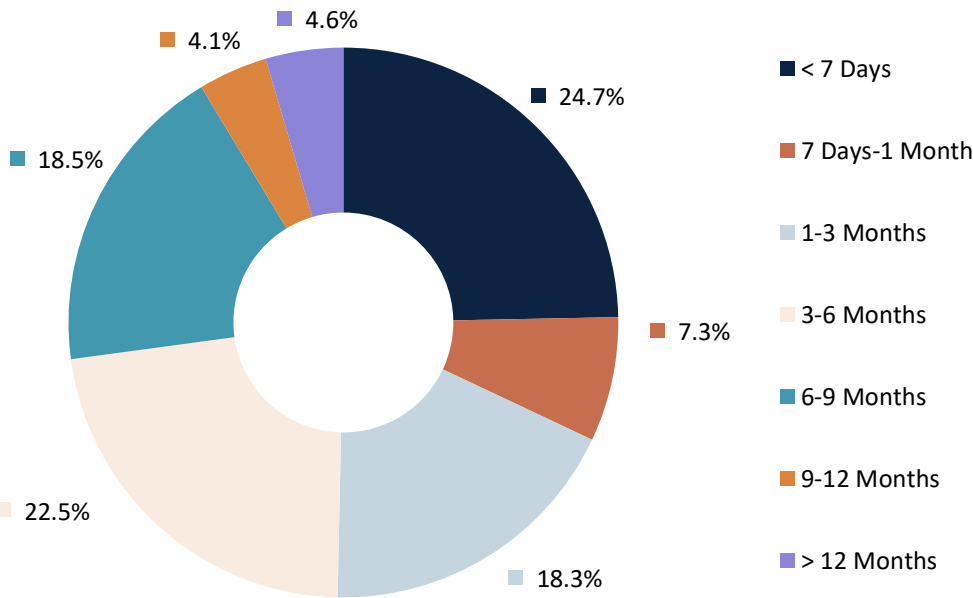

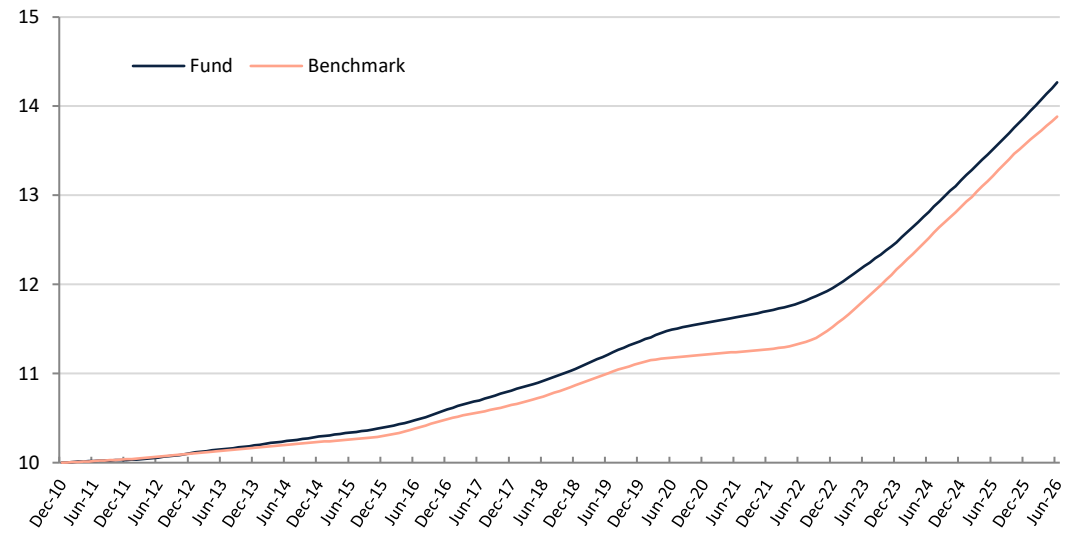

Tenor Distribuiton

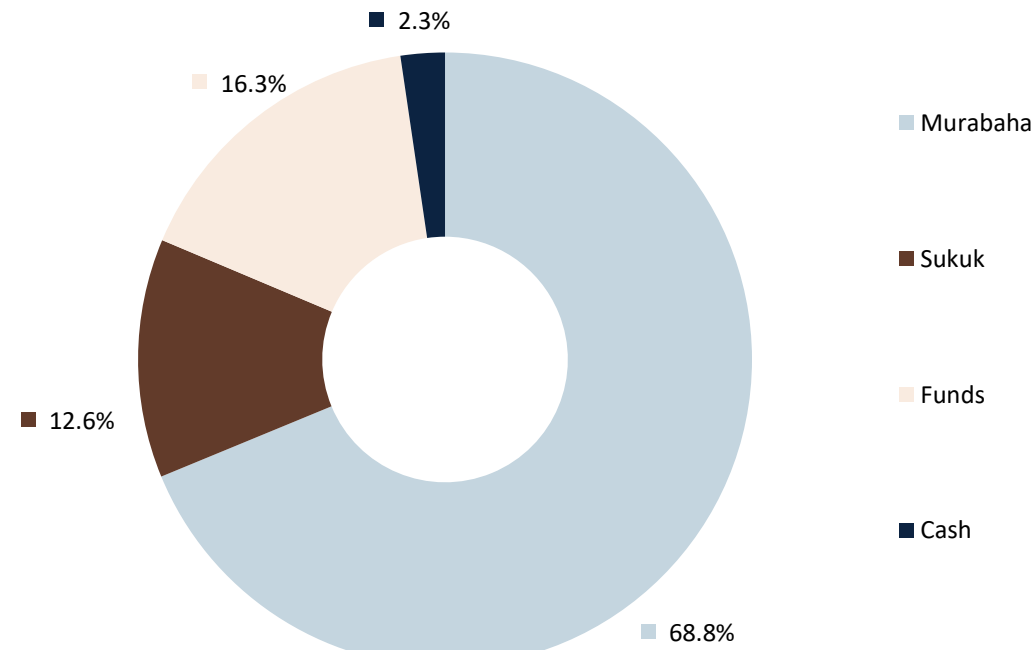
