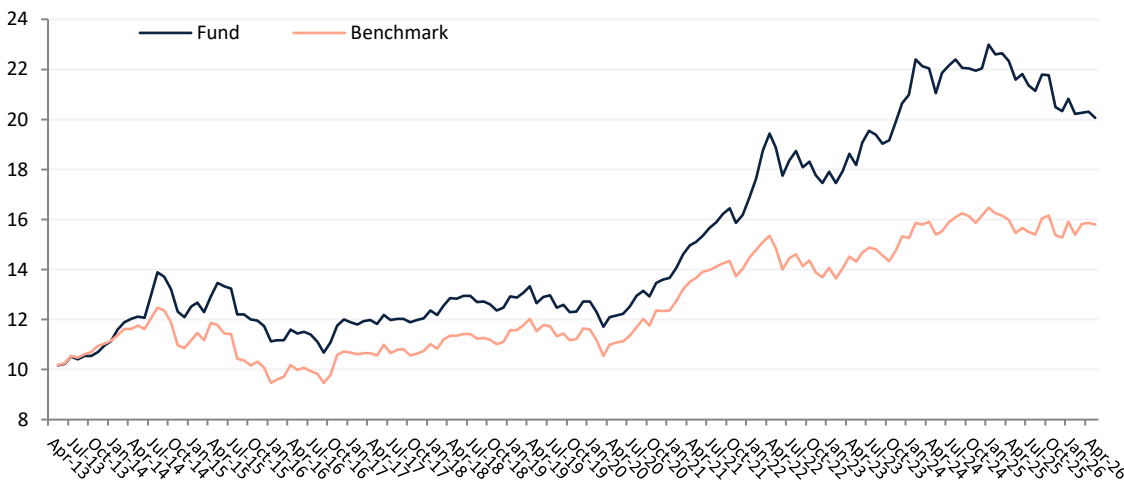

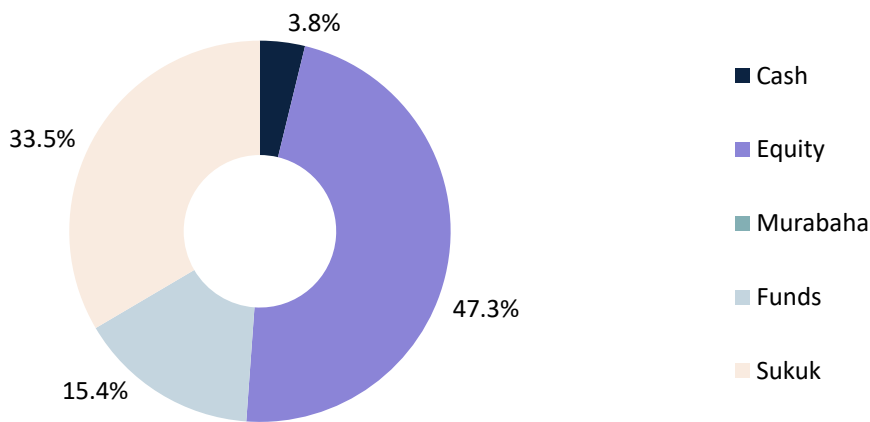

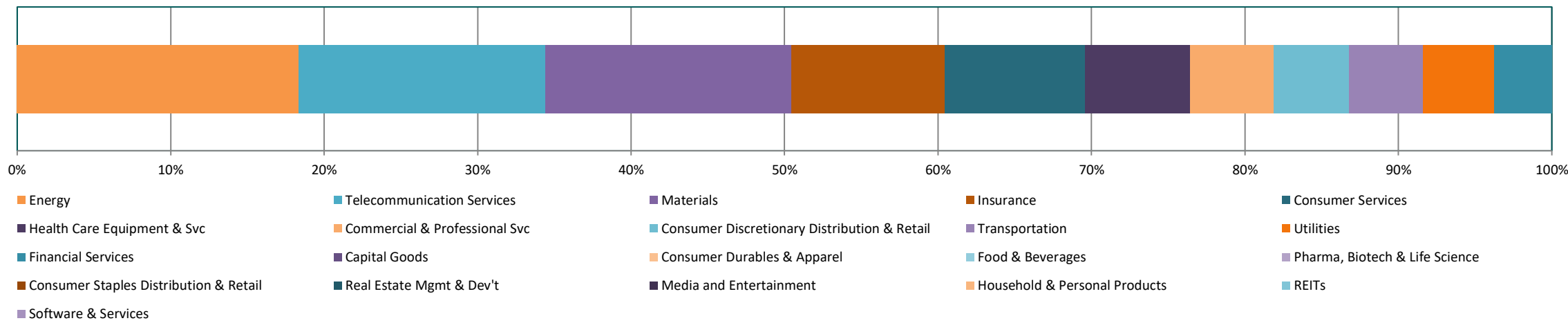
Murabaha Tenor Distribution
